Sunset Ridge School District 29 implemented a proactive program of water testing at Middlefork Elementary School. Water re-sampling was conducted on January 7, 2020 by Dan Petras of Gallagher Bassett Technical Services (GBTS) as a follow up after renovations in the plumbing system. Water sampling was originally conducted on September 21, 2017.

All sampling methodology followed protocol required by The Lead in Drinking Water Testing Bill (LDWTB) and guidelines published by the Illinois Department of Public Health (IDPH). Detailed background information on testing requirements, methodology and lead health effects are included in the initial report to the District. The lab report is provided in Attachment 1.
