2.1 Finance/Facilities Committee Meeting - July 13, 2021 APPROVAL OF MINUTES:

Mr. Zeidler moved to approve the minutes of the July 13, 2021

Finance/Facilities Committee meeting. Ms. Alpert Knight seconded the

motion. All were in favor. The Motion was approved.

There were no public comments. **PUBLIC COMMENT** 

4.1 Discussion of Sunset Ridge HVAC Issues **OLD BUSINESS:** 

Mr. Dreher provided a synopsis of the on-going issues with the Sunset Ridge School HVAC system. He noted that all systems appear to currently

be up and running as expect. He commented that the District is

simultaneously pursuing an insurance claim and potential litigation for the

costs incurred.

4.2 Long-Term Capital Improvement Plan

Mr. Beerheide reviewed the long-term capital improvement plan including recommended improvements to the Kindergarten playground at Middlefork School. Given the projected costs of a comprehensive renovation (\$400,000-\$500,000 range), Mr. Beerheide recommended breaking the improvements into stages and simultaneously seeking funding through outside sources. The Committee concurred and recommended starting the replacement of the perimeter fencing.

5.1 Solar Panel Perfromance Update **NEW BUSINESS:** 

Mr. Brian Ondyak from Performance Services reviewed the historical performance of the solar panels at Sunset Ridge School. He noted an updated payback timeline of 14-years and comments on how the actual energy consumption data for school far exceeded the modeling conducted by Wight + Co. While the energy production of the panels was just slightly below expectations, the gas consumption was significantly above expectations. The Committee requested disaggregated annual production and consumption data to better understand the cause of the issues.

Mr. Dreher reviewed a recommendation to begin a maintenance contract for the District's lift station pumps located at Sunset Ridge School. The Committee supported the recommendation.
