**2.1 Education Committee Meeting – November 12, 2019**

Mrs. Detlefsen moved to approve the minutes from September 10, 2019 and Mr. Hayes seconded the motion. All were in favor.

**3.1 Advanced Learning Program Update:**

Dr. Greene introduced Advanced Learning Program teachers Monica Brouillette and Beth Pauls, who highlighted the agenda for the evening's presentation. They went on to discuss the eligibility process, the levels of support/service delivery (pull-out, push-in and in-class differentiation), parent communication, and leadership in professional development. Dr. Sukenik also highlighted the ALP service delivery in seventh and eighth grades this year that is being provided by the ELA teachers at those grade levels. The results of the Spring 2019 parent survey were shared. It addressed communication, appropriateness of ALP instruction, and student feedback. She and the teachers are evaluating different scheduling approaches for next year. There was a request to focus on communications with students in the future.

Mrs. Brouillette and Dr. Pauls described goal areas moving forward for the ALP program: parent communications; student feedback; in-class differentiation; travel time and scheduling challenges; and additional resources for SRS students to demonstrate student growth.

Dr. Stange followed the ALP discussion with a summary of next steps for the February 2020 Education Committee meeting. The Committee will look at discipline practice/procedure, and Dr. Stange requested that Board members review the literature he had previously distributed in preparation for the February discussion.
